AFFIDAVIT FOR ARREST

(Ga. Code Ann. 17-4-45)

Personally came A J Conley, who on oath says that to the best of his/her knowledge and belief Christopher John Chad (hereinafter called the accused) between 11/18/2024 at 12:00 AM and 01/08/2025 at 11:00 PM, at [REDACTED] ALPHARETTA in FULTON county aforesaid, did commit the offense of Obscene Internet Contact With A Child - Felony (Count #1), 16-12-100.2(e)(1) in that On November 21, 2024, said accused did intentionally and willfully transmit, by computer or electronic device, a visual depiction of his exposed, erect penis to what he believed to be a 12 year old minor male. The image was sent to arouse and satisfy the sexual desire of the child. said and this deponent makes this affidavit that a warrant may issue for his/her arrest.

Probable Cause :

On February 27, 2025, I, Sgt. A Conley, received a tip (204662136) from the ICAC Data System. The tip was received by the National Center for Missing and Exploited Children (NCMEC) on January 10, 2025 and was escalated due to reports that the suspect was engaged in sexualized conversations with possible minors and that the suspect claimed to be engaged in sexual activity with minors in the past. The suspect also claimed that he worked in a school with children grades 7th – 12th. The suspect was communicating with a suspected minor in Colorado, a suspected minor in Georgia, and a predator in Washington. Once the tip was reviewed, NCMEC sent the information to Internet Crimes Against Children (ICAC) Task Forces throughout the country. GBI received the tip regarding the minor in Georgia.

GBI investigated the chats between [REDACTED] and "mr.cheese2024_qac". The chats appeared to be between an adult male around the age of 45 years old who lived in Minnesota and a minor male approximately 12 years old living in Georgia. The chats contained sexually explicit descriptions between both males and the adult male sent explicit sexual images of male genitalia and masturbation. The NCMEC tip showed that the suspect in this case was KIK username "mr.cheese2024" with a registered e-mail address of egmathteacher@yahoo.com. The victim/recipient in the case was KIK username [REDACTED] with a register e-mail of [REDACTED] using IP address [REDACTED]. GBI served several subpoenas to Yahoo, Verizon, and Comcast to determine ownership and location of the IP address and the subpoena results indicated that the victim chatted with the suspect from 11/18/2024 thru 01/10/2025 using IP address [REDACTED] at [REDACTED] located in Fulton County. The case was then transferred from GBI to the Alpharetta Special Investigation Unit.

I began analyzing the case between [REDACTED] and "mr.cheese2024". "Mr.cheese2024" made the first contact with [REDACTED] in a private message on November 18, 2024. The two exchanged a couple greetings when [REDACTED] sent a photo (ee716619-3105-4d3a-a490-e1f6b0c79588.jpg) to "mr.cheese2024" and stated "that's me btw". The photo was a selfie of a blonde hair boy between the ages of 10-12 smiling into the bathroom mirror. The conversation continued where "mr.cheese2024" asked [REDACTED] if he had any pubic hair or hair under his arms or on his legs. [REDACTED] responded "not yet" indicating that he was under the age of puberty. [REDACTED] explained that he shared a room with his 7 year old brother and they had bunk beds. "Mr.cheese2024" asked [REDACTED] "do you cum" and [REDACTED] replied "dry cum" again referencing that he was under the age of puberty. [REDACTED] asked "mr.cheese2024" how young he liked boys and "mr.cheese2024" replied "12-13". In the days that followed, [REDACTED] stated his name was [REDACTED] and "mr.cheese2024" stated his name was Chris. There are other references to age throughout the conversations like [REDACTED] being in school, Chris explaining how he didn't want to tell [REDACTED] that he was a dean of students because he might not like him. [REDACTED] stated he was in 7th grade and goes to [REDACTED] Middle School. Based on the numerous references to age throughout the chats, it appears that Chris believes he is talking to a 12 year old boy.

The conversations between [REDACTED] and Chris become sexually explicit immediately after receiving the picture [REDACTED] sent Chris on November 18, 2024. [REDACTED] explains how he was in a sexual relationship with an adult male starting at age six. Chris has [REDACTED] describe in detail the sexual relationship, to include oral sex, anal sex, and masturbation. Chris explains that he is masturbating to the descriptions [REDACTED] is giving him and that he has ejaculated. The next day on November 19th, 2024, Chris tells [REDACTED] that he can't wait to talk with him again because he wants to "jerk off again". He then explains to [REDACTED] that he wants to be in a sleeping bag with the 12 year old "kissing every square inch of your body... tongue your hole". [REDACTED] explains that he has a "boner" and Chris asks if he can "suck it". On November 21, 2024, Chris sends [REDACTED] a picture (5cb71348-62c6-4c80-a66f-515cddc98535.jpg) of his exposed penis laying on his stomach. When [REDACTED] states that he wants to "suck it" Chris states "I'd let you". Chris explains that he would like to suck [REDACTED] penis and that he wants [REDACTED] to "do me". [REDACTED] sends a picture of 12 year old boy feet to Chris and he tells [REDACTED] that he is going to "jerk off to your pics later". Chris then sends a picture of his face (2a9af355-84bc-4525-8307-0d9032757e24.jpg) to [REDACTED] and then describes imagining [REDACTED] in a sleeping bag with him naked and describing rubbing all over the boys naked body with their "boners touching". Chris then describes his penis in detail and sends [REDACTED] another two pictures (32f88602-d35f-4a3e-bda5-b8ef00221910.jpg and f161643c-d3a6-4f3b-985e-2aeee19a71dc.jpg) of his erect penis exposed outside of his black sweat pants. Chris then asks [REDACTED] if his seven year old brother is cute. He tells [REDACTED] that he would let his seven year old brother watch while they were sexual with each other and asked [REDACTED] if he thought [REDACTED] seven year old brother would join in on the sexual activity. Chris


tells [redacted] that he "cant wait to meet your boner... and maybe your brother's". Chris then tells [redacted] that he is going to "jerk off to your feet" and two hours later sends [redacted] another picture (a13b3c46-f9ba-4ffb-83bc-856e0d4b3aa3.jpg) of his exposed penis while he is laying in bed completely naked.

On November 22, 2024, Chris starts describing in detail what he wants to do sexually with [redacted] on camping trips. [redacted] asks what would we do and Chris states "I'm not sure to be honest. I'd love to lick your entire body. Massage your feet, suck your toes. Lick your balls and suck your dick. Eat your ass. Nibble on your nipples and neck. Put my tongue in your mouth. Hop you up and down on my boner. To name a few". Chris continues the sexually explicit conversation and even explains to [redacted] where there is a blind spot in the cameras at his school where they could "have fun" if he transferred to Chris' work in Minnesota. The conversations over the next few days are sexually explicit and Chris trying to figure out a way to either come to Georgia or have [redacted] meet him. On November 26th 2024, Chris explains to [redacted] how he wants him to ejaculate in his mouth and can't wait for him to not "dry cum" anymore. Chris then sends [redacted] a picture of his exposed penis in the bathroom to help [redacted] masturbate. Chris tells [redacted] that he will take any pictures [redacted] wants and [redacted] states he wants to see Chris ejaculate. Chris sends [redacted] a 14 second video (78d024cc-8a44-45c4-853c-57498feed949.mp4) of himself masturbating and ejaculating. At this point in the conversation, Chris continues to tell [redacted] how much he likes him and explains how he just wants [redacted] to make him ejaculate all the time. Chris continues to push the conversation, but [redacted] becomes more and more distant. By November 29, 2024, [redacted] stops speaking with Chris. Chris continues to try and get [redacted] to talk but [redacted] doesn't respond until January 8, 2025 stating he got his phone taken away. The conversation ends on January 8th because KIK locked out both accounts due to the sexually explicit activity with a minor.

Through police investigative tools, I was able to confirm that "Chris" was Christopher John Chad (DOB 12/25/1973). Mr. Chad does work for the dean of students for a school in Minnesota. I contacted law enforcement in Minnesota who conducted a search warrant to obtain all of Mr. Chad's electronics. During and interview with Mr. Chad under Miranda, Mr. Chad admitted to having the KIK username Mr.cheese2024 and that his e-mail address was egmathteacher@yahoo.com. Mr. Chad admitted to having conversations on KIK, but could not remember the details. Minnesota is currently investigating Mr. Chad for crimes committed in Minnesota.
